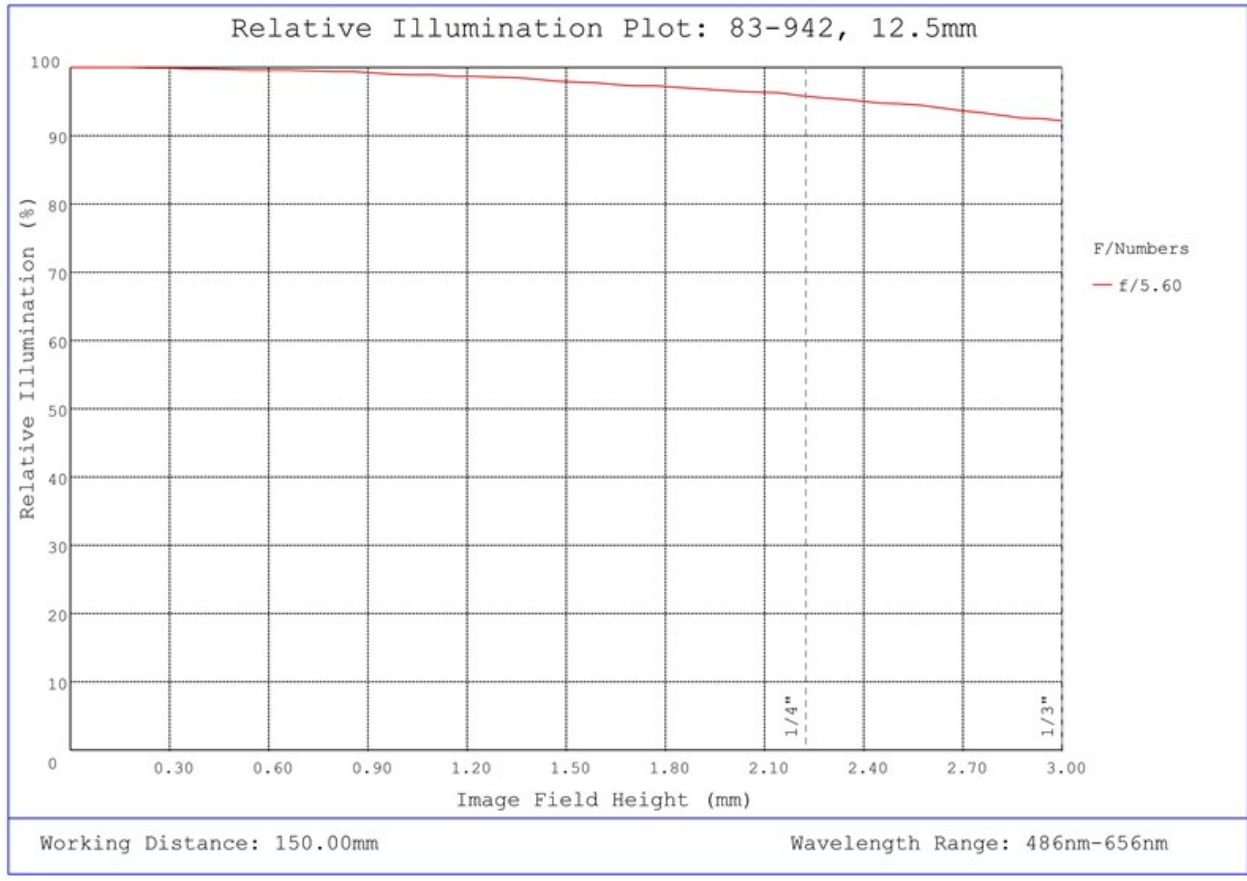

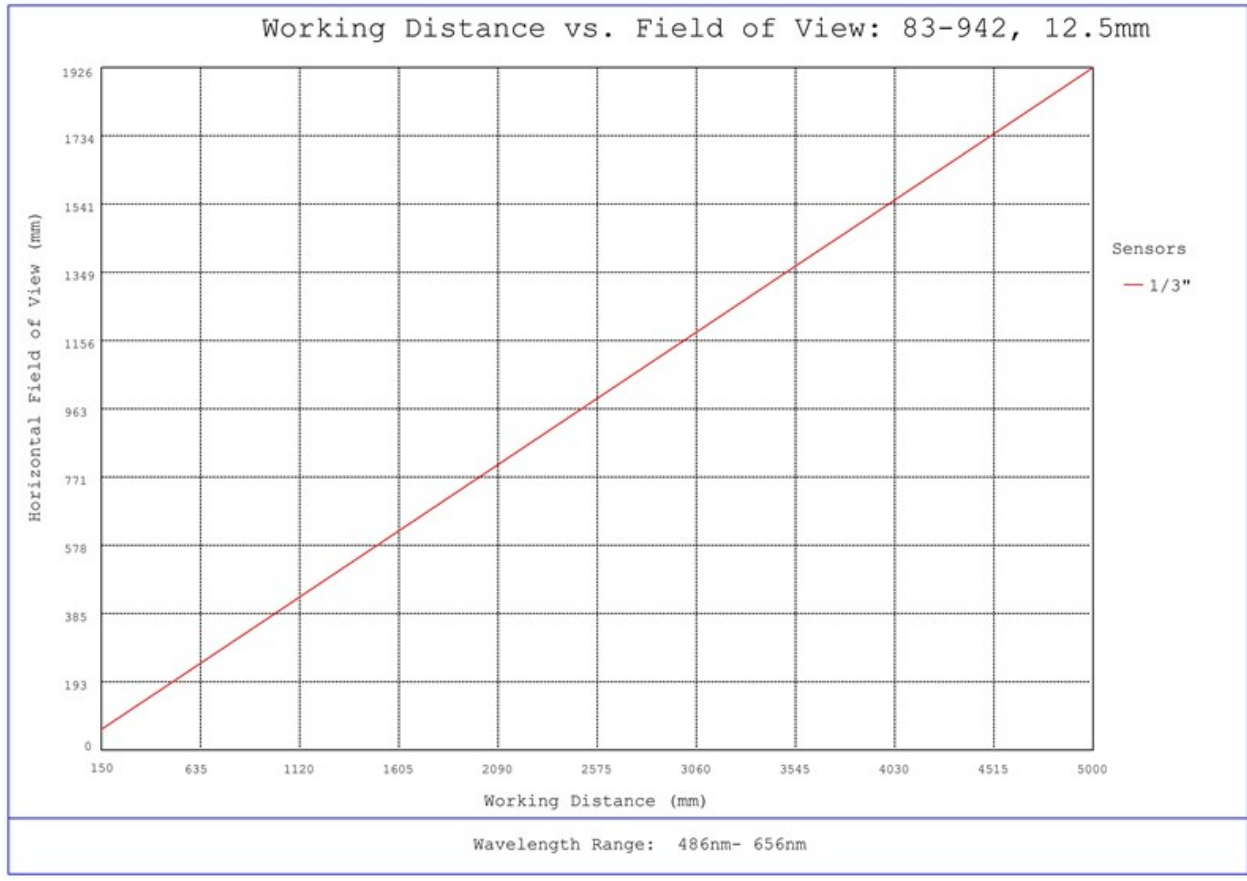

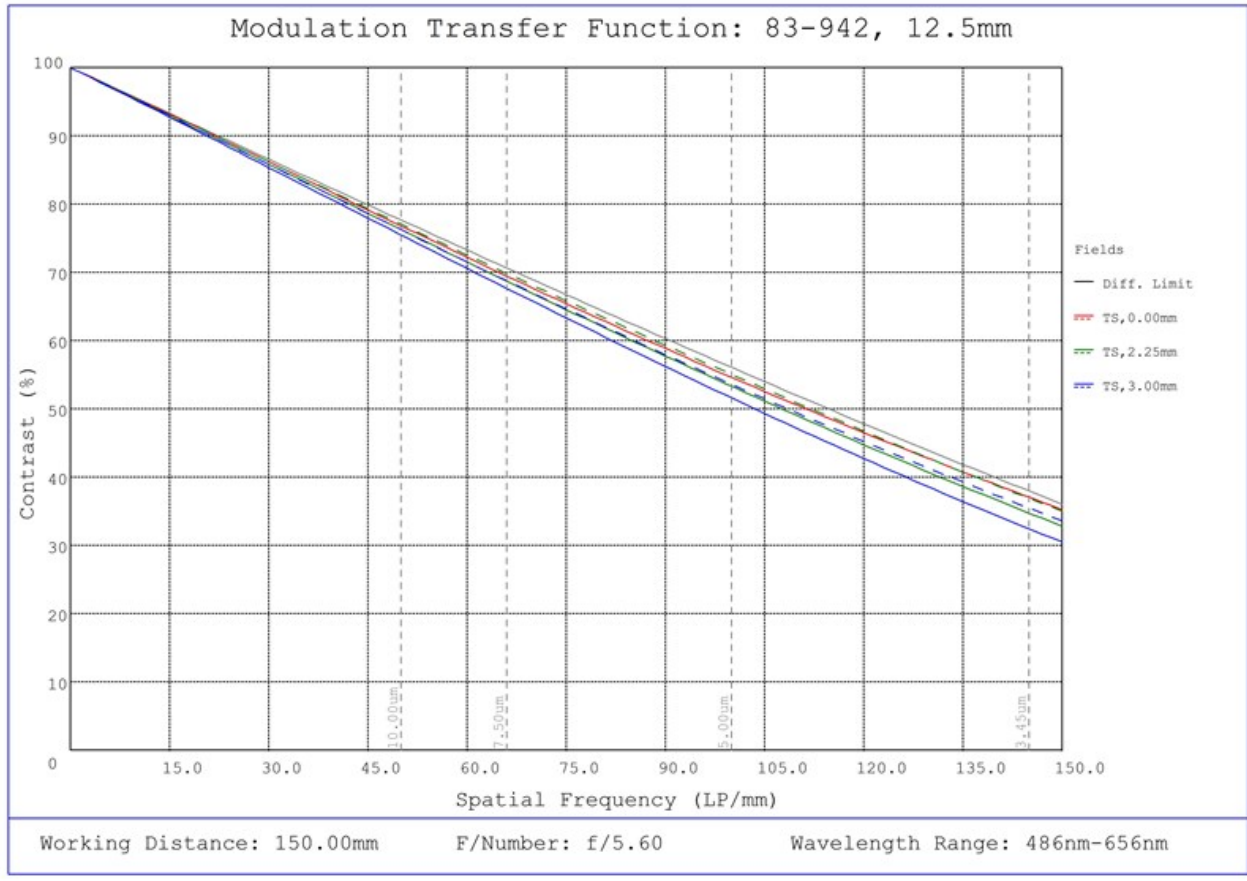

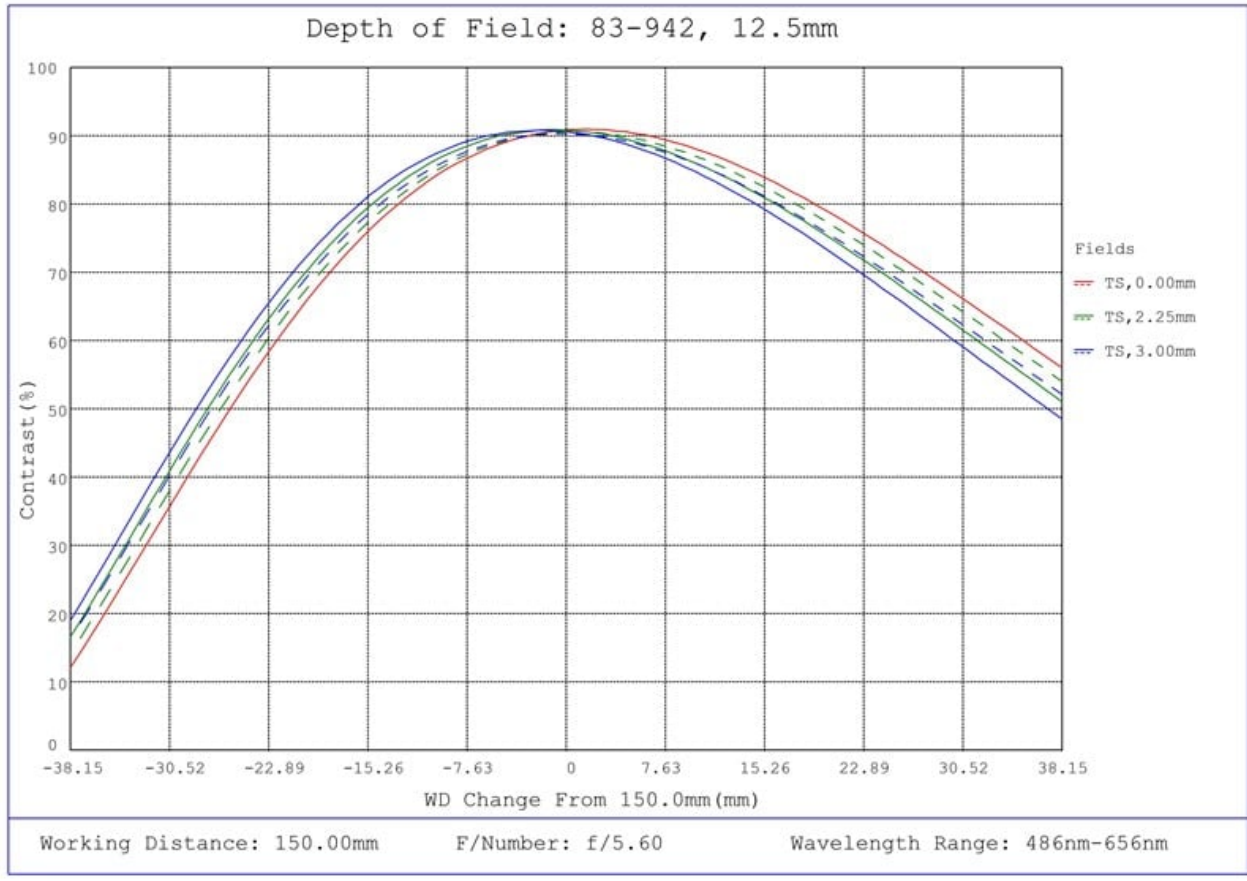
#83-942, 12.5mm FL f/5.6, Blue Series M12 Lens, Relative Illumination Plot



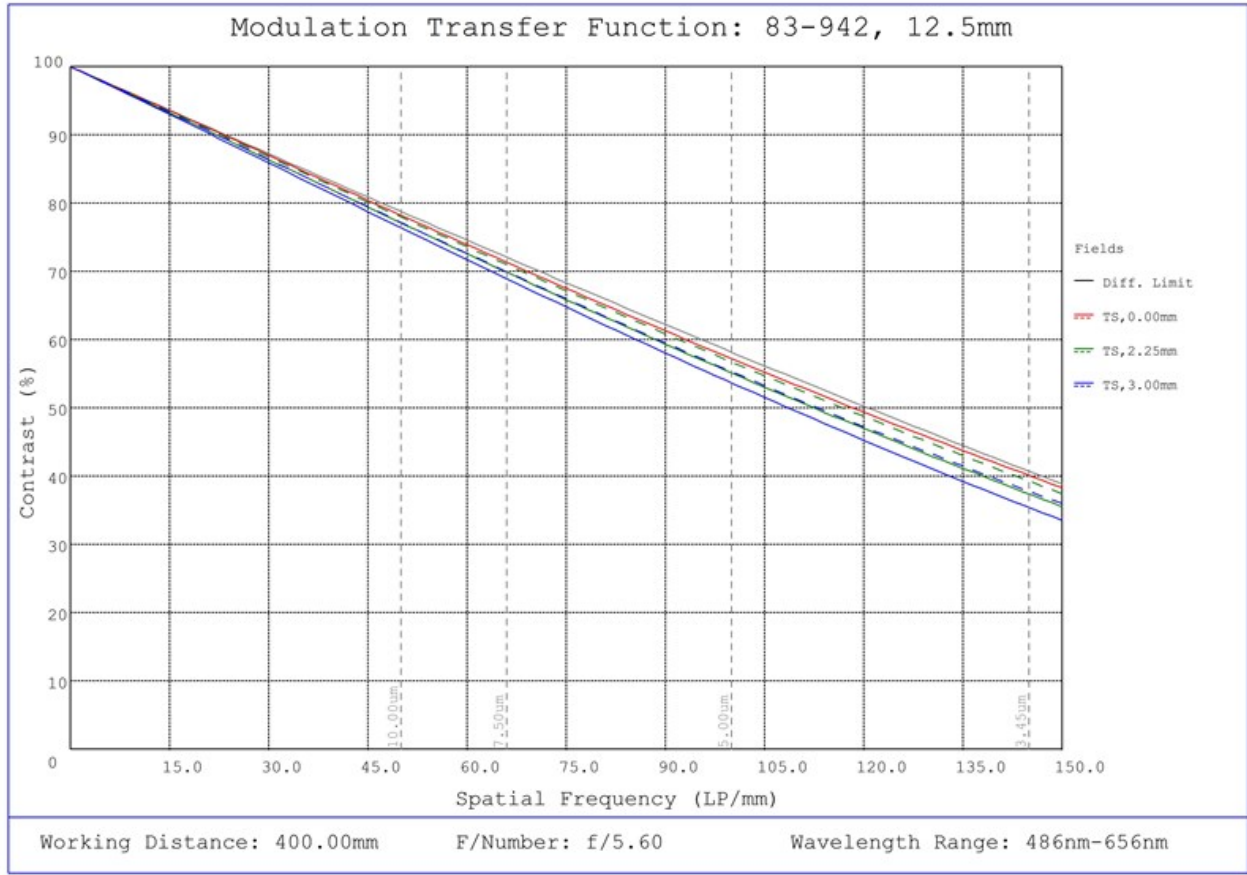
#83-942, 12.5mm FL f/5.6, Blue Series M12 Lens, Working Distance versus Field of View Plot

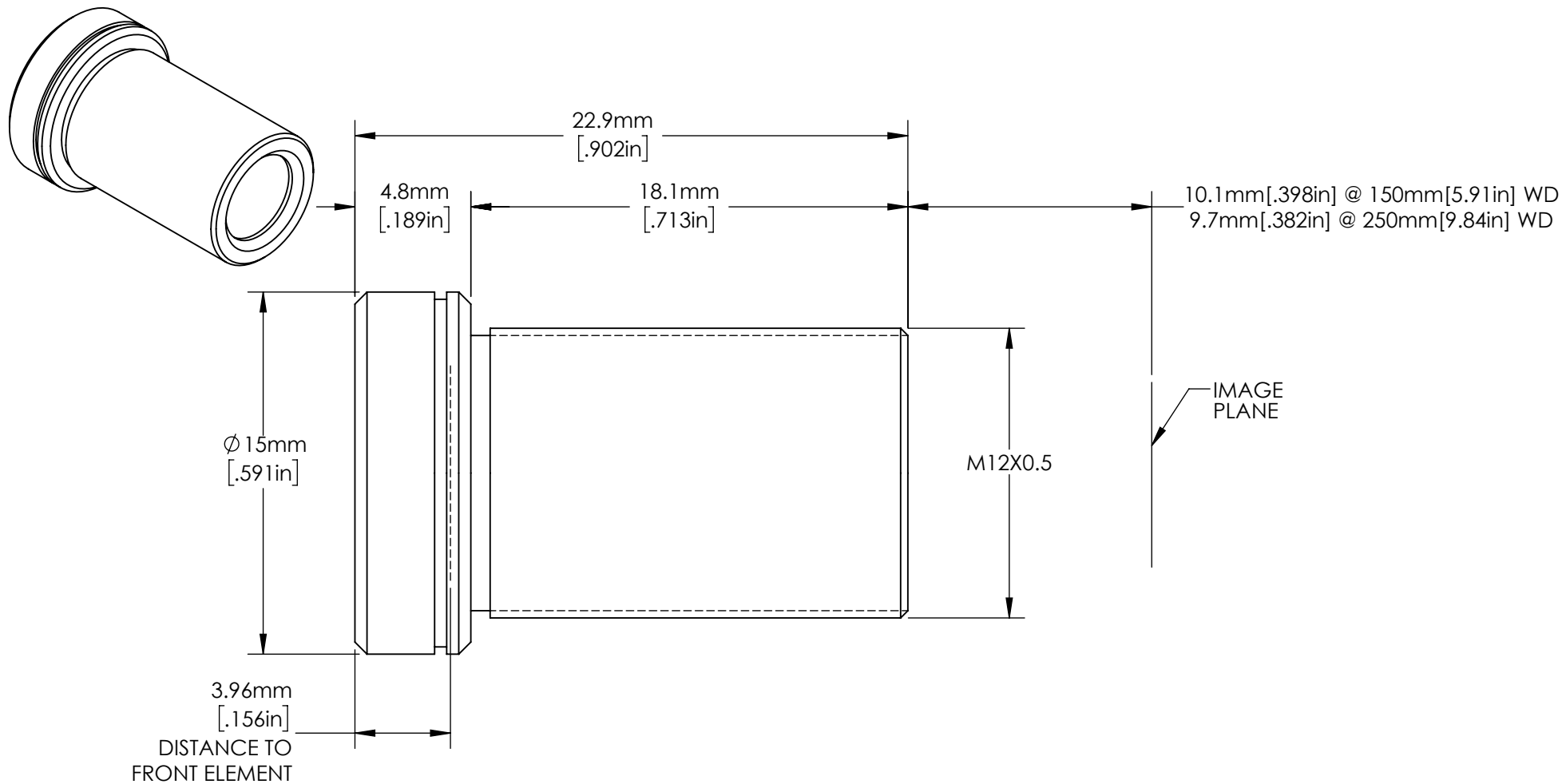
